- Stable experienced team







SECURITY MFA

To enhance platform security we have now enabled MFA Team Members. Follow the steps included in the MFA set-up to configure your authenticator app and start using MFA to securely log in to the platform.





SECURITY VIRUS SCANNING

To ensure no malicious files are being uploaded we added new security processes to check all attachments added to your forms are scanned and automatically removed if found to be malicious.





APPROVALS GROUP MANAGER


We have created the Group Manager group type in Approvals. The Group Manager possesses the same privileges as an Administrator but is limited to approvals assigned to the groups they are associated with.





APPROVALS PREVENT PAYMENT

Allow approvers to prevent any payment events on a request clarification submission. To ensure that only one payment is processed as part of the approve. You can also configure the default for this setting in the approval flow configuration of your form.





ADDITIONAL ENHANCEMENTS

User Sign Up

With the new configuration for apps user are able to self sign up to apps so Team Members do not need to manually add them.

Submission Message

We have enhanced the submission message now allowing for the ability to include a Download PDF button and a WYSIWYG editor.

GovPay Integration

Easily connect payments between OneBlink and govPay. Build simple and safe online transactional experiences for users.

Receipt Ids

Create custom receipt Ids without needing to write code. Add text, dates and random characters to create a custom receipt Id for your forms.

Information Referencing

Reference the inputs of your other elements in an information element, allowing for an easy way to summarise form content.

Date & Time Validation

We have enhanced the Date and Time start and end time validation to include inputs from other date & time elements.
